Signed Contestant Release Forms and entry fee payment must both be submitted for entry to be considered complete and eligible to be placed in the draw. Entries are limited for each day and filled on a first-come, first-served basis. Entry fee does not include rodeo admission.

- **The 71st Annual Woodlake Lions Rodeo is scheduled for May 9-10, 2026!**
- **The final list of contestants will be posted on the Woodlake Lions Club website and on Facebook and Instagram social media pages no later than Tuesday, May 5, 2026.**
- **Limit to 20 contestants per day, entry slots filled on a first-come, first-served basis.**
- **Entries will close as soon as all slots are filled.**
- **Instructions for the line-up will be sent to contestants when the entry list is posted.**

Eligibility & Rules

- Mutton Bustin' contest is open to both boys and girls, age 6 years old or under.
- Sixty (60) lb. weight limit for the contestants. Contestants will be weighed.
- Sheep will be ridden for six (6) seconds for a score.
- Contestants must ride facing forward with two hands holding onto the sheep. No ropes or rigging allowed.
- Protective helmets must be worn and will be provided.
